

- The Management should follow the provisions of the Telangana Education Act of 1982/G.O.Ms.No.1 Edn., Dated 01.01.1994 as amended from time to time and Telugu Language be imparted as I<sup>st</sup> or II<sup>nd</sup> Language compulsorily.
