Subba Reddy, s/o P. Venkata Reddy, aged 26 years, resident of 27/97, Peta, Kurnool and (5) Sri A. V. Seshachari, s/o A. 1. The Donor doth hereby create and constitute the Trust called the "GURUKRIPALI PULLA REDDY CHARITIES TRUST" and has given and transferred to the Trustees (1) G. Pulla Reddy, (2) Mst. V. Narayanasamma, (3) Sri G. Raghava Reddy, (4) Sri P. Subba Reddy, and (5) Sri N.V. Seshachariu, the sum of Rs. 5,000/- and the immovable property referred to above and the affirms that he has ceased to have any beneficial interest in the said Fund or property which shall vest immediately in and be held by the Trustees of the Trust and for use and objects hereinafter stated:

2. It is hereby declared and agreed that the said Trustees shall hold and stand possessed of the said sum of Rs. 5,000/- and immovable property, hereinafter referred to as trust fund, which expression shall also include cash or any other property and investments of any kind whatsoever into which the sum or any part thereof may be converted.
